

# **SNAKE SEASON IS BACK!**

Melbourne snake season has started off slowly this year. Temperatures have been inconsistent and readings above 18 degrees have been uncommon. However, it won't be long before this all changes, once we have some more sunny days, snakes around Sanctuary Lakes will become active.

Snake season in Melbourne runs from September to April, when temperatures are consistently above 18 degrees.

Australian snake hibernation is different to the hibernation patterns of other animals. Their hibernation may not have a definitive end point. Snakes simply shut down for most of the really cold months and become largely inactive, but they can emerge and then retreat back into their winter shelter, at will, depending on the weather conditions.

On warm days snakes will come out to bask in the sun, usually not very far from where they spent their winter slumber. Once charged up by the sun they will be keen to feed.

During this time cats and dogs are most at risk. It is recommended that you clear out any hiding spots in your yard and keep grass low. Snakes are attracted to shelter, such as piles of rocks and timber, sheets of metal, or building materials.

Snakes are protected under the Wildlife Act 1975 and it is illegal to capture, kill or harm them.

If you find a snake on your property:

- Watch it from a safe distance and do not touch the snake;
- Safely remove any people or pets from the area where the snake is;
- If the snake is visible, a qualified professional snake catcher engaged by Wyndham City can attend and remove the snake from the residential property.

#### NO PARKING IN LOADING ZONE

Please do not park in the loading zone at the car park. It makes it difficult for trucks to make deliveries and congests the roadway.

You can only stop in a Loading Zone if you are driving:

- A truck or a G-classified vehicle that is constructed mainly for carrying goods or loads (not a sedan, station wagon or motorbike);
- · A public passenger vehicle or taxi;
- A courier or delivery vehicle permanently marked in accordance with specific regulations, and you are actually loading or delivering goods or picking up or setting down people.

#### SANCTUARY LAKES CORPORATE STRUCTURE



As you are all aware we recently wrapped up 43 Owners Corporation AGM's as well as 3 Community Drop in sessions. From these meetings it was apparent that not all owners understand how Sanctuary Lakes operates, for this reason we thought we'd take the opportunity to explain it all in detail.

Above is a flow chart which shows Sanctuary Lakes corporate structure.

So lets start at the beginning. Sanctuary Lakes is made up of the **43 Owners Corporations** and each of these Owners Corporations is an incorporated member (owner) of SLRS.

Every year around August each of these Owners Corporations has an Annual General Meeting (AGM). It is at this meeting that an **Authorised Representative** for each owners corporation is elected to represent you. The authorised representative allows residents direct access to SLRS's decision making process.

An Authorised Representative is a natural person who has been appointed to be the representative of an owners corporation (incorporated member) at the AGM. Usually these people are members of the committee however, if there is no active committee it can be a lot owner who has attended the AGM. There does not need to be an active committee for the owners corporation (incorporated member) to have an Authorised Representative.

The role of the Authorised Representative is to:

- (a) act for and on behalf of that member (owners corporation) in respect of anything done or required to be done by the member under the constitution; and
- (b) represent the member (owners corporation) at meetings (including voting); and
- (c) sign documents including proxy appointments, and circular resolutions.

#### SANCTUARY LAKES CORPORATE STRUCTURE

Generally SLRS invites all Authorised Representatives to two meetings per year. One meeting held in June which reviews the budget the Board has prepared. This meeting provides an opportunity for review and feedback before the Board budget approval. The other meeting held in November is the SLRS AGM where financial results are tabled, directors are elected, statutory matters are handled and any other business.

An Authorised Representative is able to put themselves forward to be a board member in accordance with the constitution of SLRS if they wish to do so. The annual remuneration of Directors is as follows: Chair \$5,568.18, Vice Chair \$4,459.95 remaining Board members \$3,351.72.

SLRS must have at least three and no more than nine Directors at any time.

The directors include a Chair and Vice-Chair. The holders of such offices in the company are elected from the directors amongst themselves, and together with the Chief Executive Officer will constitute the executive committee of the company.

The Directors are responsible for managing and directing the activities of the company to achieve the following purposes:

- To enforce, for and on behalf of each owners corporation member, the respective owners corporation rules of that member:
- To undertake all management and administration functions for and on behalf of each member, including without limitation the collection of all owners corporation fees due and payable to each member;
- To provide the owners corporation operations for which each member, as an owners corporation, would otherwise be responsible, in a manner beneficial to the Sanctuary Lakes Resort Development and in accordance with any applicable legislation, rules and standards agreed upon by the company and the members;
- To assume the role of the principal owners corporation in a layered scheme and so provide consistency with fees, benefits and rules across all members which are owners corporations;
- To manage, and maintain in good working order, any and all assets obtained by the company and held for the benefit of members, including the common property; and
- To do all other things and exercise all powers, rights and privileges as a natural person may do or exercise, for the purpose of furthering the above objects.

Trent Curwood is the Chief Executive Officer (CEO). The CEO is responsible for ensuring the direction given by the Directors is carried out. Trent has the overall responsibility for managing the operations of the organisation and reporting regularly to the Board about any actual or potentially major risks or events that may have an effect on the operations or organisation, as well as providing status updates on projects, events and tasks.
